XVI - By-law/Rule Proposal Changes:

Team and Player Conduct

The MSMABA expects that the players and coaches associated with our organization will conduct themselves in a proper manner at all times (before, during and after). Should the conduct of a player or a team come into question a review by the three (3) League Presidents (River Valley, Central and Northwest) will be conducted to determine if a player or team is to face further disciplinary action.

The three League Presidents will review the situation presented and will make a recommendation to the MSMABA Board of Directors for action. The Board President will inform the player or team of the decision and action to be enforced.

If a player is ejected from a game, they will be ineligible (suspended) for the remainder of the game plus one additional game which is the next scheduled game for their first offense of the season. For the second

offense, the suspension is six games; for the third offense, the suspension is 12 calendar months.

Any physical altercation will result in an immediate suspension for 12 calendar months and reinstatement will be considered once the suspended member has appeared before the entire Board of Directors and requested re-instatement; any physical altercation involving an umpire will result in an immediate suspension for 24 calendar months, and reinstatement will only occur after the member presents himself to the Board of Directors at an official Board Meeting and receives approval by vote of the majority of Board of Directors members in attendance.
